- The Democratic Socialist Republic of Sri Lanka has been sanctioned a loan from the Asian Development Bank (ADB) towards the cost of Local Government Enhancement Sector Project - Additional Financing (LGESP-AF). Part of this loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible member countries of the ADB.
- The Chairman, Ministry Procurement Committee, Ministry of Provincial Councils and Local Government, Sri Lanka on behalf of Chief Secretary, UVA Provincial Council invites sealed Bids from eligible Bidders for the relevant works.
- While the detailed requirements of qualifications for Bidding are mentioned in the Bidding Document, some key qualifications are as mentioned below.
  - Bidders shall have CIDA (ICTAD) Registration Category C2 or above in the field of Water Supply and Sewerage and shall fulfil the qualification given in 3 (c) below. In case of JV between local Bidders, the lead partner should have the required CIDA (ICTAD) Registration.
  - Foreign Bidders shall fulfil the qualification criteria given in 3 (c) below. In case of JV between the local and the foreign Bidder, the local Bidder should necessarily have the specified CIDA (ICTAD) even if the foreign Bidder has the required qualifications as mentioned in the Section 3.
