**Rehabilitation of Existing Sewers in Southern Catchment Area
of Colombo Municipal Council**

1. The Democratic Socialist Republic of Sri Lanka has received a loan from the European Investment Bank (EIB) towards the cost of the Greater Colombo Water and Wastewater Management Improvement Investment Program, and intends to apply part of the loan funds to cover eligible payments under the above mentioned Contract.
2. The Chairman, Standing High Level Procurement Committee (SHLPC), on behalf of the Ministry of Public Administration, Provincial Councils and Local Government (hereinafter referred to as the "Employer") now invites sealed bids from eligible and qualified bidders for the above mentioned contract, the scope of which is briefly described below:

Rehabilitation of sewers by upsizing using trenchless (4.5 km) and open cut (1.9 km) methods. The total length will be 6.4 km from 300mm to 600mm dia VC pipes and 1000mm to 1400mm dia GRP pipes.

3. International Competitive Bidding will be conducted in accordance Single Stage Two Envelope bidding procedure and is open to all Bidders from all countries.
4. Interested bidders may inspect Bidding Documents free of charge prior to collection, and obtain any further information, at the office of "Project Director, Greater Colombo Water and Wastewater Management Improvement Investment Program, No. 86, Ananda Kumaraswamy Mawatha, Colombo 7", from 9.00 a.m. to 4.00 p.m. on working days. A complete set of Bidding Documents may be purchased on the submission of an application to the above address, and upon payment of a non-refundable fee of LKR 150,000 or USD 500 in cash to the above address or deposited to account of the Project Director-GCWWMIP and account No. 167-1001-8-9026033 at Peoples Bank, Town Hall Branch, mentioning the name of Bid. On request, against a faxed copy of the evidence of the remittance including courier charges, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. In addition, the Bidding Documents may be sent by email/WhatsApp if a Bidder request to do so. The Employer bears no responsibility for the delivery in such cases.
6. A site visit would be conducted commencing at 9.00 a.m. on 03.09.2025, from the address given in paragraph 4 above. A Pre-Bid meeting would be held on the same day at 2.30 p.m. at the Ministry Auditorium at No. 330, Union Place, Colombo 2. Bidders are well advised to attend both events.

7. All Technical Bids must be accompanied by a Bid Security in the amount as specified in the Bidding Documents (Section 2 – Bid Data Sheet).
8. Bids shall be valid up to 15.04.2026 and the bid security shall be valid up to 10.06.2026 from the date of deadline for submission of bids.
9. Bids prepared in the formats and details given in the Bidding Documents, must be delivered either by registered post/Courier or be inserted in the “Tender Box”, addressed to the Chairman, Standing High Level Procurement Committee (Attn: Chief Financial Officer), Ministry of Public Administration, Provincial Councils and Local Government, No. 330, Union Place, Colombo – 02, Sri Lanka, on or before 2.00 PM on 24.09.2025.
10. Late bids shall be rejected. Technical Bids will be opened immediately after the above deadline for submission of bids, in the presence of bidders' representatives who choose to attend.
11. The Ministry of Public Administration, Provincial Councils and Local Government will not be responsible for any costs or expenses incurred by bidders in connection with the preparation, attending pre-bid meeting and delivery of bids.
