**INVITATION FOR BIDS**

1. The Democratic Socialist Republic of Sri Lanka has received a loan from Japan International Cooperation Agency (JICA) towards the cost of the Rural Infrastructure Development Project in Emerging Regions. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Improvements to Ilugathana Road (Paththinikumtura Road) and Keenagoda - Udagama Road (Kiriwanagoda – Udagama Road) in Lunugala Pradesheya Sabha Area of Badulla District in Uva Province– Contract No. SL-P116/UP/RR/2020/03
2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
3. **The Chairman, Ministry Procurement Committee, State Ministry of Provincial Councils & Local Government Affairs** on behalf of **the Employer** now invites sealed Bids from eligible Bidders for the above road development works and some eligibility criteria highlighted in bid document are tabulated below for the construction and completion of improvements to 4.98 km of community access roads named Ilugathana (Paththinikumtura Road) (off Lunugala - Madusila road) Road and Keenagoda Udagama (Kiriwanagoda – Udagama) Road in Lunugala Pradesheya Sabha of Badulla District in Uva Province as part of Phase 1 of Project implementation. The work includes earthworks, new road sub-base and New Concrete pavement. It is proposed to construct 3m wide concrete road with 1.0m wide soft shoulder both sides. Some sections 1.0m width L walls & some sections hard shoulders. Culverts to the required places and Drainage Constructions.. (“The Works”).

6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the Standard Bidding Documents under Japanese ODA Loans for the Procurement of Small Works.
7. A Pre-bid meeting will be held on **17.05.2021 at 10.00 a.m.** at Office for the Project Implementation Unit, UVA Province, 37/2, Bandaranayaka Mawatha, Badulla. Site visit conducted by the Employer will be organized on the same date soon after the pre bid meeting and location for site visit is Ilugapathana (Paththinikumbura) Road and Keenagoda - Udagama (Kiriwanagoda – Udagama) Road.

The form of the Bid Security shall be an unconditional guarantee issued by a Bank registered & authorized by Central Bank of Sri Lanka.
